Issues included: ability of industrial lands to accommodate helicopter takeoffs and landings; safety of airport to accommodate flights and helicopter traffic; airport administration of landing fees.

Mr. Kaveh Etezdai provided comments in favour of the proposed Official Plan Amendment and Zoning By-law Amendment on the basis that the airport is the appropriate location for all types of air travel and citing the incompatibility of helicopter takeoffs and landings on industrial lands which are in proximity to residential uses.
