**AND WHEREAS** the Moose River Tourism Association is seeking funding from the Northern Ontario Heritage Fund Corporation and FedNor for a two year "Moose River Hospitality Development Project" that includes the hiring of a Tourism Development Coordinator and the joint development of a Strategic Plan for Tourism Development for Moosonee and Moose Factory;

**AND WHEREAS** the proposed project has a budget of \$373,550 with proposed financing of \$40,000 (\$20,000 per year for two years) from the Corporation of the Town of Moosonee, \$40,000 from MoCreebec Council, \$40,000 from Moose Cree First Nation, \$126,775 from Northern Ontario Heritage Fund Corporation and \$126,775 from FedNor; and

**THEREFORE BE IT RESOLVED** that Council of the Corporation of the Town of Moosonee hereby commits to contribute \$40,000 (\$20,000 per year) matching the contribution of MoCreebec Council and Moose Cree First Nation, **IF** the

*application for funding to NOHFC and FedNor is approved and the grants to proceed are awarded;*

**AND BE IT FURTHER RESOLVED** that Moose Cree First Nation will serve as the lead applicant for funding applications for the noted project, and administer the project, on behalf of and in conjunction with the Moose River Tourism Association, and that our funds will be submitted to Moose Cree First Nation, in support of the Moose River Hospitality Development Project;

**AND BE IT FURTHER RESOLVED** that Northern Ontario Heritage Fund Corporation and FedNor are hereby encouraged to accept the proposed project applications for funding and to do all possible in a timely manner to approve the requested investments so that the project can be implemented for the benefit of all the partners.
