WHEREAS Bill 191 is an Act with respect to land use planning and protection in the Far North, also known as the Far North Act;
AND WHEREAS the proposed Far North Act would apply to public lands in the Far North but not to First Nation reserves or federal lands, private land, or municipal land;

AND WHEREAS the purpose of the Act is to provide for community based land use planning in the Far North that directly involves First Nations and far north Municipalities in the planning that supports the environmental, social and economic objectives for land use planning for the people of Ontario;

THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Town of Moosonee supports the Far North Act, Bill 191 with the following considerations:

- 1. **Transportation** – Moosonee has always been a crossroads and transportation hub for this region and we would like to continue to develop transportation options throughout the region, leveraging off the Ontario Northland Rail line (a Crown Corporation), the James and Hudson's Bay oceans, and the air-access opportunities in the region. Moosonee has a modern airport, and there are opportunities to improve and expand the railway throughout the region. Ocean port and barging services continue to grow and expand in our region as well.*
- 2. **Environment** – Endangered species, plants, animals, and waterways should be considered when development opportunities arise. These should not, however, impede development where solutions can ensure sustainability. All of the waterways from far northwestern Ontario flow west to east, into the James and Hudson's Bay, and Moosonee relies on and is affected by this watershed.*
- 3. **Education** – As economic development unfolds in our region, our population needs to be informed. All educational institutions need to be apprised of impending developments so that appropriate training programs can be developed and supported. Moosonee has a college campus, and future education and training opportunities should be supported by the province.*

4. **The People** – *The people of Moosonee must be given every opportunity to be a part of economic development and the benefits that derive from this. Job creation, security and increased personal independence are some immediate benefits. Our population is comprised of approximately 85% Cree First Nations people. We have a growing workforce that needs to be ready for future employment opportunities. Our population requires support to address social issues that have been and will be on-going for many decades. Many of our professionals are transients and work in schools, government and healthcare. It is difficult to build and sustain a community under these circumstances.*
