



NOTICE OF A PUBLIC OPEN HOUSE FOR NEW OFFICIAL PLAN AND PLANNING 101 SESSION

PLEASE TAKE NOTICE that the Council of the Town of Moosonee will be holding an Open House under Section 17 of the *Planning Act*, R.S.O. 1990, C.P. 13 as amended, to provide members of the public an opportunity to learn about the proposed New Official Plan, including a workshop and an opportunity to ask questions on the process. In order to provide additional information on land use planning within the Town, the Town will also be holding a Planning 101 Session to provide members of the public an opportunity to learn about the various planning processes. There will be two separate meetings scheduled.

An Official Plan is a long-term plan that provides a policy framework for making land use planning decisions, including setting a structure for guiding growth, protecting the environment, and managing resources. In keeping with the *Planning Act*, the Township must update its Official Plan every five years. The purpose and effect of the New Official Plan is to ensure conformity to current Provincial plans, policies, and legislation and reflect the goals and values of the community. The proposed New Official Plan is intended to establish a planning and growth management framework for the Town to the planning horizon of 2051.

The New Official Plan will incorporate new and updated policies and mapping on the various focus areas identified through the Official Plan Review process, including but not limited to growth management, climate change, housing, natural heritage, transportation, natural hazards, cultural heritage, and waste management. The proposed New Official Plan will apply to all lands within the municipal boundary of the Town of Moosonee.
