2025 Road Capping Project – Granular A Placement

1. Project Overview

The Town of Moosonee is requesting proposals from qualified contractors for the supply, delivery, placement, grading, and compaction of Granular A (OPSS 1010) on various roads throughout the municipality. This project aims to improve road surfaces impacted by resource development. The Town intends to use granite-based Granular A.

2. Scope of Work

The successful proponent will be responsible for:

• Procuring OPSS 1010 Granular A granite material.

• Transporting the material to Moosonee, Ontario.

• Placement, grading, and compaction of the material on road surfaces as designated by the Town.

- Placement will occur in 4-inch compacted lifts regardless of total lift thickness.
- Final locations, width (typically 9 metres), and thickness (generally 3 to 5 inches) of placement will be determined after the tendering process is completed.
- Final grade must be 4% from center to road edge.
- All ticket slips (tonnage) must be provided to account for full quantity purchased.

Note: The Town is estimating a total of approximately 4,500 tonnes of Granular A (granite material) for this project. Final quantity will be confirmed after pricing review and project prioritization.

3. Site Conditions

Bidders are advised to consider the logistical challenges of delivery to Moosonee, including barge, rail, or winter road transportation as applicable. The Town will not be responsible for any logistical costs beyond those submitted in the proposal pricing.

Optional site visits are available upon request and are strongly encouraged. Please contact the Town to arrange.

• Health and Safety: Contractor must comply with the Occupational Health and Safety Act and ensure all staff are appropriately trained.

• Traffic Control: Contractor is responsible for implementing appropriate traffic control measures.

• Freedom of Information: Proposals are subject to MFIPPA. Any confidential material should be clearly marked.
